Board of Directors Elections

We are looking for next season's Board of Directors!!!

It's that time of the year for us to consider candidates for next season's Board of Directors. The roles and responsibilities for each position are described below.

All members with a gymnast in either the USAG JO (Level 2 and up) or Xcel programs are eligible for a Board position. Each position has a one-year term except for the President and Treasurer which have a two-year term initially and a one-year term when re-elected.

The Board of Directors meet on the 2nd Tuesday of February, May, August and November at 6:30 PM at Club Champion Pasadena.

Roles and Responsibilities of the Board of Directors

President shall preside over all meetings of the Board of Directors; shall act as the primary liaison between CHAMPION GYMNASTICS ACADEMY and CLUB CHAMPION BOOSTERS; shall be an ex officio member of all committees.

Treasurer shall manage and record all financial activities of CLUB CHAMPION BOOSTERS (i.e. create financial reports, file annual tax & non-profit forms, administer Booster Club funds).

Secretary shall document and archive activities and business of the Board of Directors and CLUB CHAMPION BOOSTERS (i.e. record meeting minutes).

Vice President in the absence of the President, shall preside over the Board of Directors meetings and complete the tasks of the president; shall be a secondary liaison between the gym and the Booster Club when needed; shall communicate information and activities of the Booster Club to the members via Booster Club website email and update website meet results.

Director of Social Events/Fundraising shall manage and/or coordinate Booster Club events and Booster Club fundraising activities (i.e. gently used leotard sales, restaurant fundraisers).
